PRIMARY SHARE SAVINGS

Rate Information: This Account is a dividend bearing account. The prospective dividend rate on the account is 0.20% with an anticipated annual percentage yield of 0.20% for the current dividend period.

The dividend rate and annual percentage yield may change. At our discretion, we may change the dividend rate on the account daily, as determined by the credit union board of directors. Dividends begin to accrue on the business day you deposit noncash items (for example, checks). Dividends will be compounded monthly and will be credited to the account monthly.

Dividend Period: For this account type, the dividend period is Monthly, for example, the beginning date of the first dividend period of the calendar year is 01-01-2023 and the ending date of such dividend period is 01-31-2023. All other dividend periods follow this same pattern of dates. The dividend declaration date follows the ending date of a dividend period, and for the above example is 01-31-2023.

Balance Information: We use the daily balance method to calculate the dividends on the account. This method applies a daily periodic rate to the principal in the account each day. You must maintain a minimum balance of \$50.00 in the account each day to obtain the disclosed annual percentage yield.

Limitations: You must deposit \$50.00 to open this account. You may make six (6) transfers from your account each four (4) week or similar period, if by preauthorized or automatic transfer, or telephone (including data transmission) agreement, order or instruction or by check, draft, debit card or similar order (including POS transactions), if applicable, made by the account owner(s) and payable to third parties. Transfers and withdrawals made in person, by messenger, by mail or at an ATM are unlimited.

SHARE SAVINGS

Rate Information: This Account is a dividend bearing account. The prospective dividend rate on the account is 0.20% with an anticipated annual percentage yield of 0.20% for the current dividend period.

The dividend rate and annual percentage yield may change. At our discretion, we may change the dividend rate on the account daily, as determined by the credit union board of directors. Dividends begin to accrue on the business day you deposit noncash items (for example, checks). Dividends will be compounded monthly and will be credited to the account monthly.

Dividend Period: For this account type, the dividend period is Monthly, for example, the beginning date of the first dividend period of the calendar year is 01-01-2023 and the ending date of such dividend period is 01-31-2023. All other dividend periods follow this same pattern of dates. The dividend declaration date follows the ending date of a dividend period, and for the above example is 01-31-2023.

Balance Information: We use the daily balance method to calculate the dividends on the account. This method applies a daily periodic rate to the principal in the account each day. HIGH YIELD SAVINGS ACCOUNT

Rate Information: This Account is a dividend bearing account. If the daily balance is less than \$10,000.00, the prospective dividend rate paid on the entire balance in the account will be 0.05% with a prospective annual percentage yield of 0.05%. If the daily balance is more than \$9,999.99, but less than \$100,000.00, the prospective dividend rate paid on the entire balance in the account will be 0.50% with a prospective annual percentage yield of 0.50%. If the daily balance is more than \$99,999.99, but less than \$250,000.00, the prospective dividend rate paid on the entire balance in the account will be 0.75% with a prospective annual percentage yield of 0.75%. If the daily balance is more than \$249,999.99, but less than \$500,000.00, the prospective dividend rate paid on the entire balance in the account will be 1.00% with a prospective annual percentage yield of 1.00%. If the daily balance is more than \$499,999.99 the prospective dividend rate paid on the entire balance in the account will be 1.25% with a prospective annual percentage yield of 1.26%.

The dividend rate and annual percentage yield may change. At our discretion, we may change the dividend rate on the account daily, as determined by the credit union board of directors. Dividends begin to accrue on the business day you deposit noncash items (for example, checks). Dividends will be compounded monthly and will be credited to the account monthly.

Dividend Period: For this account type, the dividend period is Monthly, for example, the beginning date of the first dividend period of the calendar year is 01-01-2023 and the ending date of such dividend period is 01-31-2023. CHECKING (SHARE DRAFT) - PERSONAL

Rate Information: This Account is a dividend bearing account. The prospective dividend rate on the account is 0.05% with an anticipated annual percentage yield of 0.05% for the current dividend period.

The dividend rate and annual percentage yield may change. At our discretion, we may change the dividend rate on the account daily, as determined by the credit union board of directors. Dividends begin to accrue on the business day you deposit noncash items (for example, checks). Dividends will be compounded monthly and will be credited to the account monthly.

Dividend Period: For this account type, the dividend period is Monthly, for example, the beginning date of the first dividend period of the calendar year is 01-01-2023 and the ending date of such dividend period is 01-31-2023. Dividends begin to accrue on the business day you deposit noncash items (for example, checks). Dividends will be compounded monthly and will be credited to the account monthly.

Dividend Period: For this account type, the dividend period is Monthly, for example, the beginning date of the first dividend period of the calendar year is 01-01-2023 and the ending date of such dividend period is 01-31-2023. All other dividend periods follow this same pattern of dates. The dividend declaration date follows the ending date of a dividend period, and for the above example is 01-31-2023.

KASASA CASH

KASASA CASH – MULTI LEVEL

Account Overview:

Kasasa Cash – Multi Level: A free variable rate checking account with no minimum balance requirements, that rewards accountholders with high dividends and ATM withdrawal fee refunds when they meet minimum qualifications during the account's Monthly Qualification Cycle.

Purpose and Expected Use of Account:

The Kasasa Cash – Multi Level account is intended to be the accountholder's primary checking account in which payroll transactions and day-to-day spending activities including but not limited to grocery, gasoline, apparel, shopping, dining, sporting, and entertainment transactions are posted and settled.

Commensurate with the spending activities, identified above, we expect the account's debit card to be used frequently throughout the entirety of each month and for transaction amounts to reflect a wide dollar range. Small debit card transactions conducted on the same day at a single merchant and/or multiple transactions made during a condensed time period particularly near the end of a Monthly Qualification Cycle are not considered normal, day-to-day spending behavior. For example, five debit card transactions, each for a dollar, conducted at a convenience store, two days before the end of the cycle would not be considered by our institution as normal, day-to-day spending behavior. These types of transactions, and other activities that appear to be conducted with the sole purpose of qualifying for the account's rewards, will be deemed inappropriate transactions and will not count toward earning the account's rewards. Accountholders who persist in making debit card transactions in a calculated and limited fashion in order to meet their monthly qualifications may have their accounts converted to a different checking account or closed altogether.

IDB Global Federal Credit Union reserves the right to close this account at any time, with proper notice. We also reserve the right to analyze your account activity to determine: (a) if the account is being maintained for a purpose other than day-to-day primary use; (b) if debit card activities are being executed solely for the purpose of earning the account's rewards and (c) if another account might better serve your banking needs and activities. We also reserve the right to convert the account to a different share draft account if the account does not have consistent active use over three consecutive Statement Cycles.

Our decision to close the account will not affect your existing obligations to us including any obligation to pay fees or charges incurred prior to termination. No deposits will be accepted, and no checks will be paid after the account is closed. If the account is closed, you will forfeit any rewards that have not been credited to your account. A check from our institution for the remaining balance, if applicable, will be mailed to the accountholder at the address indicated on our current records. Upon termination of your Kasasa Cash – Multi Level account, any optional add-on products / services associated with this account will also be terminated at the same time.

Dividend Rate & Annual Percentage Yield (APY)

Compounding & Crediting:

Dividends will be compounded on a monthly basis. Dividends will be credited to your Kasasa Cash – Multi Level account on the last day of the current statement cycle. If you close your account before the dividends are credited, you will not receive the accrued dividends. Dividends begin(s) to accrue on the business day you deposit noncash items (for example, checks).

"Business Day" means a calendar day other than a Saturday or a Sunday, January 1, the third Monday in January, the third Monday in February, the last Monday in May, July 4, the first Monday in September, the second Monday in October, November 11, the fourth Thursday in November, or December 25. If January 1, July 4, November 11, or December 25 falls on a Sunday, the next Monday is not a Business Day.

"Statement Cycle" means the period of time for which our credit union provides a summary of the financial activities and transactions that post and settle to the accountholder's account. Go to <https://www.idbglobalfcu.org/> or contact us at 202-623-3363 for specific Statement Cycle dates.

Balance Computation Method:

We use the daily balance method to calculate the dividends in your Kasasa Cash – Multi Level account. This method applies a periodic rate to the principal in the account each day for the period. The period we use is the Statement Cycle.

Dividend Rate & Annual Percentage Yield:

This is a variable rate account. The dividend rate and annual percentage yield may change. The dividend rate is determined at our discretion, and we may change the dividend rate on your account at any time, without any limitations, and without notice to you, as determined by the Credit Union board of directors.

When your Kasasa Cash – Multi Level account qualifications are met during a Monthly Qualification Cycle,

Kasasa Cash – Principal Rewards: daily balances up to and including \$10,000 in your Kasasa Cash – Multi Level account earn a dividend rate of 3.93% resulting in an APY of 4.00%; and daily balances over \$10,000 earn a dividend rate of 0.25% on the portion of the daily balance over \$10,000, resulting in a range from 4.00% to 0.63% APY depending on the account's daily balance. APY calculation range above is based on an assumed balance of \$100,000. Rates and rewards are variable and may change after the account is opened.
or

Kasasa Cash – Enhanced Rewards: daily balances up to and including \$10,000 in your Kasasa Cash – Multi Level account earn a dividend rate of 4.89% resulting in an APY of 5.00%; and daily balances over \$10,000 earn a dividend rate of 0.25% on the portion of the daily balance over \$10,000, resulting in a range from 5.00% to 0.73% APY depending on the account's daily balance. APY calculation range above is based on an assumed balance of \$100,000. Rates and rewards are variable and may change after the account is opened.

When your Kasasa Cash – Multi Level account qualifications are not met during a Monthly Qualification Cycle, ATM withdrawal fees are not refunded and the entire daily balance on the account earns a dividend rate of 0.05% resulting in an APY of 0.05%.

Qualification Information:

To earn your account rewards, the following enrollments must be in place and all transactions and activities must post and settle to your Kasasa Cash – Multi Level account during each Monthly Qualification Cycle:

Principal Rewards

At least 12 qualified debit card purchases
Be enrolled in and log into online or mobile banking one time per month
Be enrolled in and have agreed to receive e-statements rather than paper statements

Enhanced Rewards

At least 12 qualified debit card purchases
Be enrolled in and log into online or mobile banking one time per month
Be enrolled in and have agreed to receive e-statements rather than paper statements
At least one monthly direct deposit or ACH credit transaction of \$500 or greater

Account transactions and activities may take one or more days to post and settle to the account and all must do so during the Monthly Qualification Cycle in order to qualify for the account's rewards.

The following activities do not count toward earning account rewards: ATM-processed transactions, transfers between accounts, debit card purchases processed by merchants and received by our institution as ATM transactions, non-retail payment transactions and purchases made with debit cards not issued by our institution. Transactions bundled together by merchants and received by our institution as a single transaction count as a single transaction for the purpose of earning account rewards.

"Monthly Qualification Cycle" means a period beginning one (1) banking day prior to the first day of the current statement cycle through one (1) banking day prior to the last business day of the current statement cycle. "Banking Day" means any day on which an office of the credit union is open to the public for the purpose of carrying out substantially all of its banking functions or for processing.

"Business Day" means a calendar day other than a Saturday or a Sunday, January 1, the third Monday in January, the third Monday in February, the last Monday in May, July 4, the first Monday in September, the second Monday in October, November 11, the fourth Thursday in November, or December 25. If January 1, July 4, November 11, or December 25 falls on a Sunday, the next Monday is not a Business Day.

"Statement Cycle" means the period of time for which our credit union provides a summary of the financial activities and transactions that post and settle to the account holder's account. Go to <https://www.idbglobalfcu.org/> or contact us at 202-623-3363 for specific Statement Cycle dates.

Reward Information:

Kasasa Cash – Multi Level qualifications are waived during the initial Monthly Qualification Cycle, and you will automatically be eligible for the rewards as described below, for that Statement Cycle. Account qualifications go into effect beginning the second Monthly Qualification Cycle. When your Kasasa Cash – Multi Level account qualifications are met during a Monthly Qualification Cycle:

Kasasa Cash – Principal Rewards: daily balances up to and including \$10,000 in your Kasasa Cash – Multi Level account earn a dividend rate of 3.93% resulting in an APY of 4.00%; and daily balances over \$10,000 earn a dividend rate of 0.25% on the portion of the daily balance over \$10,000, resulting in a range from 4.00% to 0.63% APY depending on the account's daily balance. APY calculation range above is based on an assumed balance of \$100,000. Rates and rewards are variable and may change after the account is opened.
or

Kasasa Cash – Enhanced Rewards: daily balances up to and including \$10,000 in your Kasasa Cash – Multi Level account earn a dividend rate of 4.89% resulting in an APY of 5.00%; and daily balances over \$10,000 earn a dividend rate of 0.25% on the portion of the daily balance over \$10,000, resulting in a range from 5.00% to 0.73% APY depending on the account's daily balance. APY calculation range above is based on an assumed balance of \$100,000. Rates and rewards are variable and may change after the account is opened.

You will receive reimbursements up to the aggregate total of \$15 for ATM withdrawal fees incurred within your Kasasa Cash – Multi Level account during that Monthly Qualification Cycle. A maximum of \$5 per transaction incurred within your Kasasa Cash – Multi Level account during the Monthly Qualification Cycle in which you qualified. **NOTE: ATM fee reimbursements only apply to Kasasa Cash – Multi Level and Kasasa Cash Back – Multi Level transactions via ATM.** We reimburse ATM withdrawal fees based on estimates when the withdrawal information we receive does not identify the ATM withdrawal fee. If you have not received an appropriate reimbursement, we will adjust the reimbursement amount if we receive the transaction receipt within sixty (60) calendar days of the withdrawal transaction.

When your Kasasa Cash – Multi Level account qualifications are not met during a Monthly Qualification Cycle, ATM withdrawal fees are not refunded and the entire daily balance on the account earns a dividend rate of 0.05% resulting in an APY of 0.05%.

Dividends and nationwide ATM withdrawal fee reimbursements will be credited to your Kasasa Cash – Multi Level account on the last day of the current statement cycle.

APY = Annual Percentage Yield. APY accurate as of 01/01/2024. APY calculations are based on an assumed balance of \$100,000 in your Kasasa Cash – Multi Level account and an assumed statement cycle of thirty-one (31) days. Rates, rewards, and bonuses, if any, are variable and may change after the account is opened; rates may change without notice to you. No minimum balance is required to earn or receive the account's rewards. Rewards less than a penny cannot be distributed. Fees may reduce earnings. You will automatically qualify for the account's rewards during your account's initial Monthly Qualification Cycle. If the account is closed before rewards are credited, you will forfeit the rewards.

Membership eligibility requirements apply. Account approval, qualifier(s), qualifications, limits, timeframes, enrollments, log-ons and other requirements apply.

At least 12 debit card transactions monthly, online banking or mobile banking login required (Minimum once a month), e-Statement, and at least \$500 monthly direct deposit or ACH credit transaction are required qualifier(s) of Kasasa Cash Enhanced Rewards account.

Enrollment in electronic services (e.g. online banking, e-statements) and log-ons is required to meet some of your chosen Kasasa Cash - Multi Level account qualifications.

Limit of one Kasasa Cash – Multi Level or Kasasa Cash Back - Multi Level account per member number.

This account is not to be used for commercial purposes. If the account is closed, you will forfeit any rewards that have not been credited to

your account.

There are no recurring monthly maintenance charges nor any fees to open or close this account.

You may make an unlimited number of deposits in your account(s).

Cycle Date Information:

Kasasa Cash Back – Multi Level: A free variable reward checking account with no minimum balance requirements, that rewards accountholders with cash back on their PIN-based / signature-based debit card purchases, and ATM withdrawal fee refunds when they meet minimum qualifications during the account's Monthly Qualification Cycle.

Purpose and Expected Use of Account:

The Kasasa Cash Back – Multi Level account is intended to be the accountholder's primary checking account in which payroll transactions and day-to-day spending activities including but not limited to grocery, gasoline, apparel, shopping, dining, sporting, and entertainment transactions are posted and settled.

Commensurate with the spending activities, identified above, we expect the account's debit card to be used frequently throughout the entirety of each month and for transaction amounts to reflect a wide dollar range. Small debit card transactions conducted on the same day at a single merchant and/or multiple transactions made during a condensed time period particularly near the end of a Monthly Qualification Cycle are not considered normal, day-to-day spending behavior. Account qualifications go into effect beginning the second Monthly Qualification Cycle. When your Kasasa Cash Back – Multi Level account qualifications are met during a Monthly Qualification Cycle:

Kasasa Cash Back - Principal Rewards: You will receive 4.00% cash back on up to a total of \$250 qualified debit card purchases that post and settle to the account during that cycle period. A maximum of \$10.00 in cash back payments may be earned per Monthly Qualification Cycle.

or

Kasasa Cash Back - Enhanced Rewards: You will receive 5.00% cash back on up to a total of \$250 qualified debit card purchases that post and settle to the account during that cycle period. A maximum of \$12.50 in cash back payments may be earned per Monthly Qualification Cycle.

You will receive reimbursements up to the aggregate total of \$15 for ATM withdrawal fees incurred within your Kasasa Cash Back – Multi Level account during that Monthly Qualification Cycle. A maximum of \$5 per transaction incurred within your Kasasa Cash Back – Multi Level account during the Monthly Qualification Cycle in which you qualified. **NOTE: ATM fee reimbursements only apply to Kasasa Cash – Multi Level and Kasasa Cash Back – Multi Level transactions via ATM.** We reimburse ATM withdrawal fees based on estimates when the withdrawal information we receive does not identify the ATM withdrawal fee. If you have not received an appropriate reimbursement, we will adjust the reimbursement amount if we receive the transaction receipt within sixty (60) calendar days of the withdrawal transaction.

When your Kasasa Cash Back – Multi Level account qualifications are not met during a Monthly Qualification Cycle, no cash back payments are made, and ATM withdrawal fees are not refunded.

Cash back payments and nationwide ATM withdrawal fee reimbursements will be credited to your Kasasa Cash Back – Multi Level account on the last day of the current statement cycle.
